WARRANTY BOND

KNOW ALL MEN BY THESE PRESENTS, That we **Marina Community Partners LLC**, a Delaware limited liability company, and **Safeco Insurance Company of America**, a corporation duly licensed to do business in the State of **California**, as Surety, are held and firmly bound unto **Marina Coast Water District**, as Obligee in the penal sum of **Three Hundred Ninety Eight Thousand Two Hundred Dollars (\$398,200)** to which payment well and truly to be made we do bind ourselves, our and each of our heirs, executors, administrators, successors and assigns jointly and severally, firmly by these presents.

WHEREAS, the said Principal provided Performance and Payment Bonds to the Obligee to guarantee completion of the following improvements

Approximately 1,919 LF of 8-inch sewer main; approximately 485 LF of 15-inch sewer main; approximately 1900 LF of 24-inch sewer main; approximately 1,315 LF of 27-inch sewer main; approximately 24 LF of 30-inch sewer main; approximately 13 sewer service laterals ranging in size from 4” to 6” in diameter; and 34 manholes

WHEREAS, the Obligee requires the Principal to furnish a bond conditioned to guarantee that said improvements shall be free of defects in workmanship and materials which may become apparent for a **one-year period** following the Obligee’s acceptance of the improvements.

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH that, If the Principal shall indemnify the Obligee for all loss that the Obligee may sustain by reason of any defective materials or workmanship which become apparent during the said period then this obligation shall be void, otherwise to remain in full force and effect.
