9. Action Items:

A. Consider Adoption of Resolution No. 2018-16 Regarding a Variance to the Application of MCWD Water Code Section 3.36.030.W.2.a for the Junsay Oaks Development Project and Consider Adoption of Resolution No. 2018-17 to Modify the Infrastructure Agreement Between MCWD and CHISPA in Order to Implement the Variance Request:

Mr. Michael Wegley, District Engineer, introduced this item and explained the variance request and how the project's distinguishing characteristics make it unique from other multi-family projects.

Mr. Wegley explained that there would be an Implementing Agreement that would be part of the Infrastructure Agreement, and this Implementing Agreement would have a future performance assured by a License Agreement. He said that under the License Agreement, CHISPA would own and maintain the sub-meters; be responsible for reporting sub-meter usage monthly; perform water conservation actions; and, test the sub-meters annually. The Board asked clarifying questions.

Mr. Alfred Diaz-Infante, CHISPA President, thanked the Board for bringing this back and thanked staff for the additional work they did to help with this variance. He stated that the rents are set by HUD and they have an affordability contract for 55 years so no one will profit from this project. Mr. Diaz-Infante added that all savings would remain with the property.

Mr. Andy Hunter, Woodson Engineers, stated that they used similar housing to compare water usage.

President Moore suggested adding language to Section 2.1 of the License Agreement regarding CHISPA providing an annual report of the savings and how those were returned to the Junsay Oaks tenants.
