C. Consider Adoption of Resolution No. 2018-27 to Approve and Implement the Compensation Portion of the Classification and Compensation Study:

Ms. Jean Premutati, Human Resources/Customer Relations Manager, introduced this item explaining what information was included in the comparisons. Vice President Shriner inquired on the ranking of the comparator agencies. Mr. Van Der Maaten answered that, due to some concerns that Montecito and Yorba Linda might have skewed the numbers, the agencies were ranked on how they fall in the comparisons with 1 being the highest and 12 being the lowest. He said that in many cases, Montecito and Yorba Linda were ranked the lowest and did not skew the numbers.

Director Gustafson made a motion to adopt Resolution No. 2018-27 to approve and implement the compensation portion of the Classification and Compensation Study. Director Lee seconded the motion. Mr. Van Der Maaten asked for clarification if the motion was to implement to the Median or the Average.
