Subject: Ord Village Lift Station - Force Main Alignment Change

Dear Mike:

The purpose of this letter is to document the design scope change for the Ord Village Lift Station. The Ord Village project as originally scoped was for connecting the force main to the M1W Seaside Interceptor pipeline, and adding variable frequency drives and controls to the existing pumps. After meeting with Monterey One Water, the scope was revised to be replacement of the existing force main. After laying out the replacement force main alignment and considering construction near the gas main, and maintenance access through the trees and on the Seaside Senior Living property, an alternative alignment was proposed in Monterey Road. The revised alignment is now in Monterey Road, Bougainville Road, Buna Loop and Kiska Road.

The Ord Village alignment changes have required two additional rounds of field surveying to update the topographic base map and amend the Ord Community easements, and will require additional drafting effort to prepare plan and profile sheets along the new alignment. Fortunately, Whitson Engineers had an aerial survey scheduled for the Lower Stilwell project, so these areas will be completed in the next few weeks. The estimated cost for the additional Ord Village effort is \$22,800, as broken out on the attached fee estimate. We request an amendment to that task order to cover the additional effort.
