Draft Minutes Joint City/District Committee Meeting

December 12, 2018

1. Call to Order:

The Joint City/District Committee was called to order at 5:39 p.m. In attendance were:

- Committee members: MCWD Director Tom Moore, MCWD Director Jan Shriner, and Marina Councilmember Gail Morton.
- Staff: Keith Van Der Maaten and Paula Riso attended for Marina Coast Water District, and Layne Long attended for the City of Marina.

- 2. Public Comments on Any Item Not on the Agenda:

Councilmember Morton wished everyone a happy holiday season and Merry Christmas.

3. Approve the Draft Minutes of October 24, 2018:

Councilmember Morton asked that page 2, item d.3 be changed to "does not serve provide water to the former Fort Ord." Director Moore made a motion to approve the minutes of October 24, 2018 as amended. Councilmember Morton seconded the motion. With a vote of 2-Ayes, 0-Noes, 1-Abstained (Shriner), 1-Absent (Brown), the October 24, 2018 minutes were passed.

Mr. Van Der Maaten stated that they were still working with jurisdictions on service agreements. Discussion followed. Councilmember Morton said that the City wrote a letter opposing any extension of FORA, opposed any extension of the CFD, and opposed any other organization taking over after FORA.
