1. Call to Order:

4. Receive an Update on the Public Education and Outreach Efforts:

Mr. Van Der Maaten gave an update on the status of Public Education and Outreach Efforts:

- MPWSP Outreach met with Governor's office in April and was a positive meeting. Made public comments to the County Planning Commission regarding the MPWSP. Met with Paul Scuito to discuss his meeting with Coastal Commission.
- News Bureau issued news release for AEM 2.0 and was interviewed on KSBW for the 6 pm news.
- Outreach Meetings to Other Jurisdictions –met with City of Monterey, Seaside and Del Rey Oaks. Gave presentation at FORA Admin Committee to all jurisdictions.
