Draft Minutes Budget and Personnel Committee Meeting

December 7, 2021

1. Call to Order:

The December 7, 2021 Budget and Personnel Committee meeting was called to order at 6:30 p.m. by President Shriner. In attendance via Zoom teleconference were:

- Committee members: President Shriner and Director Cortez
- Staff: Remleh Scherzinger, Kelly Cadiente, Rose Gill, and Paula Riso
- Public members: None
- 2. Public Comments on Any Item Not on the Agenda:

There was no public comment.

3. Approve the Draft Minutes of the November 2, 2021 Meeting:

Director Cortez made a motion to approve the minutes of November 2, 2021. President Shriner seconded the motion. The minutes were approved by a vote of 2-Ayes (Cortez, Shriner), 0-Noes, and 0-Absent.

4. Receive a Covid Update:

Ms. Gill commented that staff was 100% vaccinated and their vaccine cards are on file with Human Resources.

5. Receive an Update on the District's Vacant Positions and Succession Planning:

Ms. Gill noted there were several positions open in the engineering department, operations and maintenance department and one in the finance department. Interviews for the operations and maintenance positions are scheduled over the next couple of days and staff is reviewing applications for the Accountant position. She noted there was one internal candidate for the Senior Engineer position. Mr. Scherzinger stated that he and Ms. Gill were working on a RFP for a head hunter to help fill the District Engineer and Director of Administrative Services positions as they were critical lead positions. Ms. Gill stated that staff has created a draft succession plan and is currently reviewing it.

6. Receive Information Regarding the District's Cost Centers:

Ms. Riso stated that the 1998 Water Wastewater Agreement specifies in Section 7.1 that MCWD will keep cost centers separate until the agreement expires. She also said that the Board adopted Ordinance 43 to keep the cost centers separate. Ms. Cadiente explained that there were cost centers for sewer and water and those will always be separate. Both Ord and Central Marina each have a set of water and sewer cost centers so that neither area is paying for the maintenance and cost of the other. She stated that eventually, the depreciation of the infrastructure will bring both areas into similar costs and then Ord and Central Marina can be combined without any disadvantage.
