Draft Minutes Executive Committee Meeting

December 5, 2023

1. Call to Order:

The December 5, 2023 Executive Committee meeting was called to order at 6:40 p.m. by President Shriner. In attendance were:

- Committee members: President Shriner and Vice President Cortez
- Staff: Remleh Scherzinger, Roger Masuda, and Paula Riso
- Public members: None

2. Public Comments on Any Item Not on the Agenda:

There were no comments made.

3. Approve the Draft Minutes of the November 7, 2023 Meeting:

Vice President Cortez made a motion to approve the minutes of November 7, 2023. President Shriner seconded the motion. The minutes were approved by a vote of 2-Ayes (Cortez, Shriner), 0-Noes, and 0-Absent.

4. Discuss the Draft Agenda for the December 18th Board Meeting:

Mr. Scherzinger reviewed the draft agenda for the December 18th Board meeting with the Committee members. The Committee members suggested a few changes to the agenda.

5. Receive Draft DEI Policies for Discussion:

Mr. Scherzinger noted that there were three sample DEI Policies for the Committee to review and let staff know what they are interested in. Vice President Cortez stated that the District should not draft a DEI Policy until the vacant Human Resources position is filled and there is someone to champion the policy. Discussion followed. President Shriner shared a DEI Policy to include in the samples for review. Once the Human Resources position is filled, a workshop will be scheduled for the Board to discuss what DEI stands for.

6. General Manager Update:

Mr. Scherzinger stated that the District staff is working on the following items:

- there is a tentative schedule for Strategic Planning with the first workshop in February and a second in March, with adoption anticipated in April;
- starting to kick the 2025 CIP planning into gear;
- the rates are anticipated to be set in April;
- A1/A2 Tanks are slightly off-schedule by 1-2 months as we wait for the Motor Control Cabinet to arrive and relocate some assets off the CSUMB property and onto City of Marina's property;
- working on a cross connection with Seaside Muni for potable water supply in emergencies;

- working on another cross connection with Monterey One Water who has a permit with the
 Department of Drinking Water that requires that they have a secondary water supply for
 CalAm should there be a failure of the Pure Water Monterey system and it be contaminated
 with an emergency being declared.
- 7. Identify Agenda Items for Future Committee Meeting:

Nothing was identified.

8. Committee Member Comments:

President Shriner wished everyone Happy Holidays and mentioned that she had been receiving some positive comments from the public. She also noted that she had been talking with some City of Seaside Councilmembers and encouraged them to work together with the City of Marina on a broad spectrum to strengthen the public presence.
