# **General Specification**

**Model:** Unit shall be a new current year model.

**Sweeper:** Sweeper pick up attachment shall be a hydraulic attachment, fitted to a bucket to allow debris to be contained within the bucket.

**Warranty:** Shall be stated in writing on the form provided.

**Delivery:** Awarded bidder must deliver the skid steer to the Districts Corporation Yard located at 2840 4<sup>th</sup> Avenue, Marina CA. Delivery of unit is due no later than June 15, 2018.

**Training:** Upon delivery to the District, bidder shall provide training to District Operators on proper operation of skid steer and sweeper attachment, and when and how to maintain equipment.

Bidder shall provide proof of minimum coverage of:

- \$2,000,000 Commercial General Liability
- \$1,000,000 Automobile Liability
- \$1,000,000 Workers Compensation Insurance

Manuals: All manuals shall be included with skid steer equipment and sweeper including: One (1) Service manual

One (1) Parts Manual One (1) Operator's Manual

# **Compact Skid Steer Bidding Specifications**

### Intent

The intent of the specifications is to provide for the purchase of one (1) new Rubber Tread Skid Steer and one (1) new sweeper attachment for the skid steer for the use in construction within water and wastewater facilities and to allow Operations and Maintenance staff to utilize the sweeper attachment to cleanup beach sand from around the District's main office and dirt and debris from streets when performing underground repairs.

The District has evaluated different models of skid steer equipment and has determined which specifications are best suited for the District's needs. In comparing bids, comparisons will not be based solely on price. The successful bidder will be judged based on price, product, quality, warranty and delivery. The district reserves the right to reject any or all bids and to waive any minor technicalities. If determined to be in the best interest of the District, the bidder submitting the lowest bid that meets the requirements of the District will be awarded a contract upon approval from the District's Board of Directors.

### Equivalency

Bids will be accepted for consideration on any make or model that is equal or superior to the attached specifications. Decisions of equivalency will be at the interpretation of the District.

### General

All bids shall have sufficient technical literature to allow the District to make a reasonable determination of compliance of the specifications listed for the equipment. Failure to provide a completed bid and technical literature will result in the bid being considered non-responsive.
