• Install approximately 3,500 linear feet of new 18-inch ductile iron pipe (DIP) water main in Inter-Garrison Road, from approximately 200' east of Shoonover Road to approximately 500' west of the intersection with Sherman Blvd. in East Garrison. The new main will connect to existing 12" water mains at both its eastern and western ends. This work includes all associated fittings, valves, appurtenances, pavement removal and restoration, reconnecting existing mains and services along these pipes, and abandonment grouting of existing water mains within the right-of-way.

(Labor Code 1770, et seq.). It shall be mandatory upon the Contractor to whom the is awarded and upon any subcontractor under the Contractor to pay not less than the said specified rates to all Workers employed by them in the execution of the Work.
