# Pre-approval Required for New Landscape Cash Incentive Program

istrict customers who conserve water by replacing thirsty lawns with droughttolerant ground covers, changing inefficient irrigation controllers to evapotranspiration-based controllers or simply installing a rain shutoff switch to an existing sprinkler system can get a cash incentive after receiving pre-approval and filling out an application form. To encourage

50 cents per square foot of lawn being replaced, and 25 cents per square foot of sprinkler system area being converted to drip irrigation.

So, before you start your landscape project, call a District water conservation staff member at 883-5905 to learn if your project qualifies and to schedule a site survey, which is required prior to applica-

## Fats, Oil and Grease Clog Sewers

Tats, oils and grease (FOG) can build up in your sewer pipe (lateral sewer line) that extends from your home to the sewer main beneath the street. FOG can block these lines and cause wastewater backups, especially during cooler weather.

While the District is responsible to perform periodic cleaning of the sewer mains and responds to blockages in these mains on a 24-hour basis, you are responsible for the maintenance of your lateral sewer line.

By keeping fats, cooking oils and grease out of your sewer, you will greatly reduce the threat of clogging the line. So, along with food scraps, pour your cooking oil and grease into a container that you can dispose of in your garbage can.

As daylight decreases and the weather cools, the amount of water landscape plants need is greatly reduced. You can eliminate water waste and safeguard the health of your plants by reducing the amount of water you apply to your landscape. The District's new Lawn Irrigation Guide, which is available at www.mcwd. org, takes the guesswork out of irrigating. The District encourages customers to install a rain shut-off switch that automatically stops unnecessary irrigation when it's raining.
