Subject: Receive Updated GPCD, Water Production, and Water Consumption Data

Summary: In response to the ongoing drought, the State Water Resources Control Board (SWRCB) approved an emergency regulation that directs water purveyors to electronically report monthly water production and consumption figures. Also to be reported to the SWRCB is an estimate of the amount of water used each day by residential customers. This estimate, called "residential gallons per capita per day", or R-GPCD, more accurately portrays water use by individuals and allows communities to compare their efforts accurately with others around the state.

In support of the SWRCB actions, Marina Coast Water District staff has increased their efforts to compile and submit the required production, R-GPDC data, and other required monitoring reports each month. Staff will provide tables and charts that show water production figures through April 30th. Staff will also include tables and charts showing the gallons-per-capita-day (GPCD) and R-GPCD data that has been compiled. The documents are entitled:

Subject: Receive a Verbal Update on the July 19, July 26, and August 3 WCC Working

Group Meetings

Summary: On July 19, 2017, staff met with the Commissioners and worked to draft an ordinance revising the requirements to retrofit properties upon resale, remodeling, and change of use.

Of primary consideration was the need to lower the flow requirements, listed in the MCWD Water Code, for water fixtures to levels equivalent to current or proposed standards for new construction in residential and commercial projects (California Green Building Code).

On July 26th, the Working Group participants reviewed the 2017 WCC Goals and Objectives, then drafted revised tables illustrating those projects completed, projects having some progress made, and those projects that remain in progress. The participants also drafted revisions to the WCC Working Group calendar, forecasting topics of discussion and meeting dates for August, September, and October 2017.

Details of the August 3, 2017 working group meeting were not available at the time of this Staff Report. An update of that meeting will be provided verbally.

Subject: Review and Revise 2017 WCC Goals, Objectives

Summary: The Executive Committee of the Board of Directors requested staff to take an agenda item to the September 6, 2016 meeting that allowed the Board to discuss options and provide direction to the WCC on how to best provide the most value to the Board and the District in the upcoming year. In the agenda item, the Board was asked to review the WCC's listing of 2016 goals and objectives and, if appropriate, provide guidance to staff and the Commissioners on which goals and objectives to prioritize.

The outcome of that meeting was a request that the WCC review the whole water conservation program and develop a new list of goals and objectives for the upcoming year. Then, a report on those goals and objectives would be presented to the Board of Directors. The Directors stated that they would like to know more details about the actions proposed or taken in support of the goals. The Directors requested staff identify any work to be done in support of the goals, by the Commissioners verses work to be completed by staff.

At several Commission meetings and WCC Working Group meetings since the September 2016 Board meeting, the Commissioners have successfully listed and prioritized goals and objectives for 2017.

In preparation for a second presentation to the Board in the fall of 2017, one that highlights the many accomplishments achieved to date through 2017, staff has drafted this agenda item.

The attached Table A shows both a new, revised list of goals that remain as top priorities, and a list of the original goals that have been completed.

The Commissioners are asked to review the new, revised lists of Goals and Objectives, then discuss the accomplishments achieved to date, add any additional conceived goals to the list, remove goals found to be inappropriate, before revising the list further to clarify the prioritization of any new and remaining goals not yet achieved.
