Draft Minutes Budget and Engineering Committee Meeting

January 9, 2024

1. Call to Order:

The January 9, 2024 Budget and Engineering Committee meeting was called to order at 5:32 p.m. by President Morton. In attendance were:

2. Public Comments on Any Item Not on the Agenda:

3. Approve the Draft Minutes of the December 5, 2023 Meeting:

President Morton made a motion to approve the minutes of December 5, 2023. Vice President Shriner seconded the motion. The amended minutes were approved by a vote of 2-Ayes (Morton, Shriner), 0-Noes, and 0-Absent.

4. Finance Department Update:
