RESOLVED by the Board of Directors ("Directors") of the Marina Coast Water District ("District"), at a special meeting duly called and held on September 3, 2009 at the business office of the District, 11 Reservation Road, Marina, California as follows:

WHEREAS, the District is a member of the Association of California Water Agencies (ACWA); and,

WHEREAS, that membership includes membership in the NWRA, which assists in work toward the development, protection and management of water resources at the federal level; and,

WHEREAS, California is allowed four positions on the NWRA Board and a Policy Development Committee position of which, three directors and one alternate position are to be nominated and elected by ACWA membership; and,

WHEREAS, nominees must receive support from their board either through specific board action or a resolution and application forms must be received by ACWA by September 10, 2009.
