Director Lee made a motion to authorize the General Manager to engage special litigation counsel. Vice President Gustafson seconded the motion.

A draft resolution was handed out for review. Mr. Masuda stated that in reference to the Ag Land Trust and CPUC claims, Mark Fogelman's firm, Friedman and Springwater, will continue to represent the District. He said that for purposes of the new claim, item 3-A4, California American Water Company vs. MCWD (Complaint for Declaratory Relief), James Markman of Richards, Watson & Gershon, will be the lead retained as special litigation counsel on that matter. Mr. Masuda stated that staff is requesting the Board authorize the General Manager to engage Richards, Watson & Gershon as special litigation counsel for the matter of California American Water Company vs. MCWD (Complaint for Declaratory Relief); and to continue to work with Friedman and Springwater as the lead on the other litigation matters.
