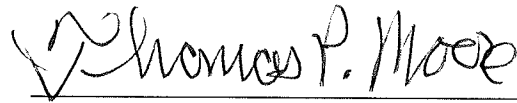
President Moore thanked staff for all their work and patience with the Board.
