## 1. Call to Order:

The Joint City/District Committee was called to order at 5:04 p.m. by Chair Moore. In attendance were:

- 2. Public Comments on Any Item Not on the Agenda:

3. Approve the Draft Minutes of October 22, 2014:

Vice Chair Morton made a motion to approve the minutes of October 22, 2014. Director Lee seconded the motion. With a vote of 3-Ayes, 0-Noes, 0-Absent, 1-Abstention (Brown), the motion was passed.

- 4. The Joint Committee May Discuss the Following Items of Mutual Interest to the City and District:
  - a. CalAm Desal Application and Coastal Commission Permit Update; Slant Wells:

The Committee reviewed the 2013 and 2014 Well Production Reports for the Central Marina and Ord Community.

e. Discuss Water Allocation for the Roller Hockey Building:

Vice Chair Morton commented that she was charged with looking into the Roller Hockey water allocation that was possibly allocated to another project. Chair Moore requested staff provide an updated list of water allocations to the developments in the Ord Community.

f. Addressing Rate Increase/Fire Service Fees:

Vice Chair Morton commented that it was onerous to place the high costs of water bills on low income housing tenants. Chair Moore explained the rate structure, including the capital component charges, and that the District cannot subsidize any ratepayers, even if they are low income. Discussion followed.

g. Median Irrigation and Run-Off:

Vice Chair Morton commented that the City was aware of the issue and that City and District staff had looked into it. There was discussion on drought tolerant plants for the medians.
