District customers now have several additional options that make it more convenient to pay your monthly bill.

We now accept **credit or debit card payments** (MasterCard or VISA):

There is no fee for this service. Payments made over the phone are posted to your account immediately. To use our web site, visit www.mcwd.org and click "Online Bill Pay" on the lower right.

To sign up for automatic payments, all we need is a completed form, available at www.mcwd.org or the District office, and a voided check.

If you are running errands and don't want to drive all the way to the beach, **Rabobank on Reservation Road** in Marina (next to Walgreens) will accept your MCWD payment.

Of course, you still have the option to pay by mail or in person each month.

MCWD Turns 50 Years Old

The Marina Coast Water District (MCWD) is 50 years old this year. The District was created by the voters on March 17, 1960.

MCWD started with a number of small wells. In 1983, as a result of seawater intrusion,

MCWD abandoned its 180-foot wells and switched to 400-foot wells. Over the next 6 years three wells were drilled in the deep aquifer, which provides water to Marina today.

In 1970, Marina voters responded to an increasing number of septic system failures and requests to meet the community's growing sanitation needs by authorizing the construction of a sewage treatment plant and disposal system. MCWD operated this plant until 1993 when an agreement with the Monterey Regional Water Pollution Control Agency made it possible for Marina's wastewater to be treated at the regional treatment plant. Though MCWD ceased treating wastewater, it continues to operate and maintain Marina's sewer system.

In 1997, the District began operating a desalination plant, capable of produc-

ing 13 percent of our water supply. The plant operated for several years, until electricity costs made operations uneconomical. Also in 1997, the Army contracted MCWD to operate its water and wastewater systems on the former Fort Ord. By combining services and resources, MCWD has improved water distribution and storage efficiency and decreased operating costs.

After 50 years, MCWD is still governed by an elected five-member Board of Directors and continues to provide safe, reliable water to our customers, as was the goal in March of 1960.

DISTRICT GOES GREEN WITH NEW WATER DISINFECTION METHOD

Use of chlorine gas, a potentially hazardous water disinfectant, has been eliminated by MCWD. The District has built onsite generators which produce chlorine from simple table salt and provide a safe, "green," more cost effective disinfection method. Additionally, carbon emissions

Is Fog a Potential Community Water Source?

District Assists CSUMB with Fog Water Collection Project

CWD is hosting a collection device at the District Beach Office on Marina State Beach to study how much water is potentially collectable from fog within the Monterey Bay area.

The California State University Monterey Bay Fog Water Collection Project, under the direction of CSUMB's Dr. Daniel Fernandez, Chair, Division of Science and Environmental Policy, involves the deployment of Standard Fog



Collectors in various locations.

The devices consist of a net with a surface area of one square meter mounted at a height of two meters. The amount of water collected is measured with a tipping bucket rain gauge.

A coastal site, such as MCWD's Beach Office, provides a significant location from which to deploy a sensor.

Regional Urban Water Augmentation Project (RUWAP) Work Progresses Along Gen. Jim Moore Blvd.

s part of MCWD's effort to provide recycled water for landscaping, parks and golf course irrigation, construction is in progress on nearly two miles of pipeline within the future alignment of General Jim Moore Boulevard. (All recycled water pipe is purple in color to distinctly identify it.) The current project is one of many planned to meet RUWAP goals. Bayonet and Black Horse golf courses, California State University Monterey Bay facilities and the Seaside Highlands neighborhood already have installed recycled water pipe.

MCWD has been working for several years on the pipeline backbone, which will

deliver recycled water from the Monterey Regional Water Pollution Control Agency treatment plant north of Marina to central Marina and the former Fort Ord.
